

# Certificate III in Early Childhood Education and Care CHC30121

**Updated June 2025** 

## **Aim**

This qualification reflects the role of workers in various early childhood education settings who work within the Education and Care Services National Regulations and the National Quality Standard requirements. Please note – this course is delivered as a partial and full qualification for VETDSS. Students who enrol in the partial option will have the opportunity to complete this qualification after completing their secondary school studies.

Support the implementation of an approved learning framework and children's well-being, learning, and development. Depending on the setting, educators may work under direct supervision or autonomously. In this course, you will undertake the following:

- 1. Practical activities
- 2. Research and projects
- 3. Written activities/multiple choice questions
- 4. Oral presentations/verbal questioning
- 5. Group work/working as a team.

Credit towards VCE /VCE VM:	This course does not offer scored assessment. A student who achieves a Units 3 and 4 sequence may be eligible for an increment towards their ATAR.  The increment is awarded by the Victorian Tertiary Admissions Centre (VTAC).  Increments for VCE VET programs will be calculated using 10% of the lowest study score of the primary four.
Cost:	Students need to check with their home school regarding cost of course and required resource costs.
VCE VM:	This program is suitable for the industry skills component of a VCE-VM course.
